Mike Aldridge, President, called the meeting to order.

SECRETARY REPORT

- Minutes from the previous meeting were approved as read. Ray Sparks made a motion to accept , Shain Stephens seconded and motion carried.

FINANCIAL REPORT

- Finances look good right now, to date all bills are paid
- 110 members have paid dues which are more at this point than in 2019.
- Lucas Equine is considering a corporate membership for 2020
- Budget Review: Difference from last year was to costs from finishing in the black
- Discussed needs for 2020 to present to stockholders

STAFF REPORT:

- Jimmy Fuller stated that we are going to have more PAR 3 tournaments on Fridays in 2020.
- Round up prices from pennies to even money (example if the cost is 5.04, round to 5.05 for easier accounting purposes).

OLD BUSINESS

- Reaching out to Jason Crisp, HCHS Golf Coach, for assistance in reaching youth for golf team and memberships.

NEW BUSINESS

- Kelly Kendall asked the board permission to have a beginner ladies league on Sunday evenings. One week would play 4 holes and next 5 holes. Cost would be \$4 to cart on those evenings. Will advertise and call prospective players and utilize Hank Whalen to help with instruction.
- Membership Cards: Ideas were discussed to better capture players and guests at golf and pool. No decision was reached.

STOCKHOLDERS MEETING HELD JANUARY 15TH

The Annual Stockholders Meeting was held on 1/15/2020 at 7 PM.

President Mike Aldridge called the meeting to order. The minutes from last years stockholders meeting were read and approved by Shain Stephens and Bob Seefeldt.

The Board Members present at the meeting were Mike Aldridge, Ray Sparks, Ray Huellemeier, & Shain Stephens. Members present including board members, 12.

The Financial Report was give by David McIlvain & Ray Sparks. Information included the following:

- on a scale on 1-10 we had a 7.5 year
- 186 members 2019 vs. 190 2018
- 27 members that didn't return but picked up 24 members in 2019
- Money - 2019 we lost \$3600 for the year, 2018 we earned \$8800
- Reasons that accounted for the loss of 2019 was the loss on the 3M Membership
- 12/31/19 – we had \$37,0000 in bank, this is due to members paying their dues early. This isn't extra money, but it helps us out.
- November wasn't good for people playing golf
- December was probably one of the best months we have had .
- JoJo Gunn, 12/31 was a huge financial success
- Food and Alcohol were down slightly, but golf was up \$8,000
- Rental Events were down however, the contract has now been adjusted to accommodate smaller parties for less periods of time.
- Grounds & water was \$7,000 down
- Pool income was down, lessons, guest fees, etc. but pool expenses down.
- lifeguard payroll down
- grounds, pro shop payroll up
- golf merchandise purchases were up
- saved \$3800 on our credit card fees management system
- Summary – Golf play is down in America 35% in the last 10 years. 1200 courses have closed in the last ten years..... so we are doing pretty good.
- Loan , City Bank, 2/18/12 is the date of our loan \$333,309 original loan, down to \$203,000 down on the principle. For years we just paid on the interest . So we have paid 90K down on the principle.

For those of you that are interested, we will be placing an apparel order for Foot Joy on **Monday, March 2nd**.

Ordering at the same time will enable us to save money on shipping.

The way it will work is this:

- Come to the club between now and March 2nd to look at the catalog that Jimmy has available.
- By having an account with Foot Joy, the club receives a discount and this will allow you to purchase their quality men's and women's apparel, rain suits, outerwear, etc at an extremely competitive price.
 - Example – the shirts above are from their Essentials Collection and have an SRP of \$65 plus tax. We can sell you that same shirt for around \$48.00 plus tax (maybe less depending on how low we can get the shipping cost)
- Shoes are not discounted as deeply, but there is a substantial discount and we can order.

We will not be stocking shoes or apparel at the club this year, so this is a good opportunity to you save some money.

So, get to the club between now and **March 2nd** to put in your order.

Golf News and Notes

- **New HDCP System**

- Most of you have probably heard that the USGA has adopted a new handicap system called World Golf Handicap System. You can go to the USGA or the KYPGA website for more details.
- For those of you with the old GHIN app on your phone, you probably need to go in and update it. Once you've done that, you may need to know your GHIN number before being able to access. If so, Jimmy can provide you with that.
- Please note, most of you have your GHIN fee included in your dues and you will not see any disruption. For those that pay separately, please make sure to do so as soon as possible.
- If by March 15th, if we have not received your GHIN payment, we will have to deactivate you in the system so as not to be charged from the USGA. You can get reactivated simply by paying your GHIN fee to the club.
- Also please note that in all of the Men's Tournaments all players have to have an established USGA HDCP by June 1st to participate in the Calcutta's.

- **Pro Shop/Men's Locker Room Cleanup**

- We are in the process of going thru these areas and throwing out items that we no longer use.
- If you feel like you might have something up there in danger of being tossed, we ask that you please come and get it.
- For some reason, there seems to be an over abundance of men's golf shoes laying around in the locker room. If you have shoes not in a locker, they need to find a home.....quickly.
- We're going to toss out all "homeless" shoes on March 1st, so you have a little time.

- **Pro-Shop Sign-In Sheet for Golf**

- We are asking for your cooperation this year as we re-implement the sign-in sheet for golfers. We ask that when you come in to pay that you tell the staff person your name and they will write it down on the sheet. Obviously, a lot of you are well known by most, but we have several new members and pro shop staff each year and this will help us with the following:
 - It will help all our staff get to know the members and their names regardless of whether they are new or let's say "seasoned".
 - It will ensure that we track rounds played and reconcile with our receipts to find any discrepancies and correct.
 - It will help us make sure we're capturing guest fees correctly as well as ensure that a Harrison County resident that is not a member is playing a maximum of 3 times.

Thanks for your cooperation. Looking forward to a great 2020.

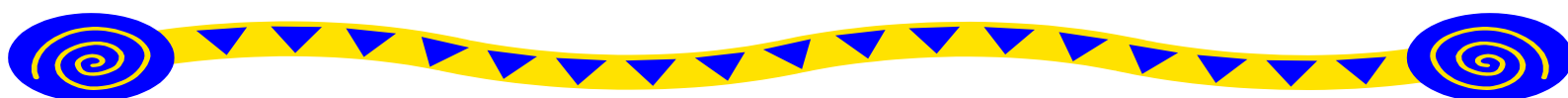
